Interpretation

In this Privacy Policy:

- **"Person" means an individual, a firm a company or an unincorporated association, and "Persons" shall be construed accordingly.**
- **"Register" means completing the registration process.**
- **"Registered Account" means your use of the websites through the username chosen by you during the registration process.**
- **"You" or "Your" means the Person using this site.**
- **"Your Communications" means any communications received or sent by you through the service including e-mails and other electronic messages.**
- **"Your Material" means any material which originates from You.**
- **"We" "Us" "Our" "Guitar Weekends" and "The Company" means Guitar Weekends Limited (registered in England no. 4580570).**
